Background History

The J. Neils Lumber Company was incorporated in Sauk Rapids, Minnesota on March 23, 1895 by Julius Neils and Thomas Shevlin. The company expanded in 1899 with the purchase of a second mill located at Cass Lake, Minnesota. In 1919, the company repurchased the Libby Lumber Company in Libby, Montana from the Shevlin Company. Once the timber supply was exhausted in Cass Lake area, the Cass Lake operation ended in 1925. With the close of this mill, the company desired a second mill. Walter Neils heard about the financial difficulties of the Western Pine Lumber Company in Klickitat, Washington and suggested the company look at this location. After touring the entire timbered area, J. Neils Lumber Company took possession on June 1, 1922.

The Western Pine Lumber Company acquisition included the railroad and its equipment, sawmill, planing mill, title to the mill property (including Klickitat townsite), logs in the woods and at the mill, and the storage yard, timberland, title to W.R. Hervey contract. A new company was incorporated and named the Klickitat Log and Lumber Company so that J. Neils Lumber Company's new railroad would not be under the regulations of the Washington State Railroad Commission. The sawmill operated three shifts per day, six days a week. The first logging was done by donkey engines, then by horse logging and eventually by tractors. On September 2, 1927 the mill at Klickitat burnt down. The rebuilding of the plant cost \$1,100,000 and business resumed in 1928.

After the Great Depression, long-term planning resumed at Klickitat. The large volume of timber available and the absence of other operators in Klickitat drainage area gave rise to the thought of permanency for the plant. After inspection, selective logging was concluded to be the best method for achieving permanency for the plant. Arrangements were made with the U.S. Forest Service to conduct a logging and mill study to determine whether cutting only fifty percent of a stand would be economically sound. The advantages gained were two-fold, namely developing accessibility to the entire area at a doubled rate and salvaging many million feet of timber which otherwise would have been lost. Selective logging was begun in 1939.

Aside from the Libby and Klickitat operations, J. Neils Lumber Company owned the Montana Light and Power which was purchased in 1944. On January 1, 1957 the J. Neils Lumber Company merged with the St. Regis Paper Company.

Scope and Content

The J. Neils Lumber Company papers cover the years 1895-1976. The records are divided into eight series: J. Neils Lumber Company, Libby, Klickitat, Selective Logging, Montana Light and Power Company, St. Regis Paper Company, Financial Records, and Miscellaneous.

The J. Neils Lumber Company series is arranged alphabetically, 1919-1974. The series includes correspondence, forest inventories, reports, research and tax information.

The Libby series is arranged alphabetically, 1951-1971. This series contains information about J. Neils Lumber Company operations in Libby and Troy, Montana. The records include reports, machinery specifications, cost summaries, studies, correspondence, and information about the plywood plant in Libby.

The Klickitat series contains records from the Klickitat townsite operated by J. Neils Lumber Company. The series is arranged alphabetically, 1922-1974. Records include townsite studies, Klickitat Log and Lumber Company correspondence, tests, forest inventories, mill site studies, proposals and timber sales information.

The Selective Logging series is arranged alphabetically, 1931-1972. The records include correspondence, agreements, reports, and statements regarding J. Neils Lumber Company's selective logging policy.

The Montana Light and Power Company series is arranged alphabetically, 1925-1976. Records include by-laws, correspondence, reports, agreements, rate schedules, and machinery specifications.

The St. Regis Papers Company series contains the records of J. Neils Lumber Company after J. Neils Lumber Company merged with St. Regis in 1957. The series is arranged alphabetically, 1956-1972. The records include budget of earnings statements, mill studies, timber of log prices, annual program reports, correspondence, and timber purchases information.

Financial Records series, 1895-1959, arranged chronologically. The records include yearly statements, financial statements, agreements, trial balances and bill of sales.

Miscellaneous series includes a book by Paul Neils entitled *Julius Neils and the J. Neils Lumber Company*, college transcripts, science center dedication program, 75th anniversary program for St. Paul/Tacoma division, and correspondence about the records of J. Neils at the University of Oregon and the University of Wyoming.
