Agency Responsibilities

- Conduct hearings statewide and resolve state employees' appeals of state agency actions under the civil service rules.

Statutory Authority

The Personnel Appeals Board's enacting statute is RCW 41.64.010. The Personnel Appeals Board is scheduled to sunset on July 1, 2006, pursuant to RCW 41.06.111, whereupon the powers, duties and functions will transfer to the Personnel Resources Board.

Organization Chart and Budget

The Personnel Appeals Board has 10.9 full time employees. The Executive Secretary, pursuant to WAC 358-01-060, directs and supervises all administrative activities of the Board. The current Acting Executive Secretary is Anita Hunter who was appointed to act in Executive Secretary Don Bennett's stead while he is on active military duty. He is slated to return in February or March of 2005.

The Personnel Appeals Board is a single program agency with a biennial budget of approximately 1.75 million dollars, which is sourced by the Department of Personnel Services Account.



Most Pressing Issues or Challenges

The Board is scheduled to sunset on July 1, 2006, and the Board will cease taking new appeals on June 30, 2005. The greatest challenge will be to resolve all pending appeals before the Board within the statutory timeframe. The Board is also concerned with achieving the most efficient transition possible to the Personnel Resources Board.
